Reports / Requests from Fire Department Chiefs

- Chief VanEtten
 - Alex Roberts presented to the SFD Board about lighted vests for fire police. Would like to purchase four at \$76/per.
 - o Country Home Security installation of two cameras one in each office cost is \$820.60.
 - Discussion about hoses and quotes the department is super low on hoses, and all that is on trucks and rack has been inventoried. Cost approximately \$5,000 to replace hoses.
 - Discussion about airpacks have 13 packs total, with a few recently serviced. There are three newer ones from the Don's Dairy fire. Cost for one airpack is \$7379. \$1459.25 for a bottle – Bill noted that we are good with what we have on hand. Discussion only need one pack, and should always maintain/have six on hand.
 - Discussion about gear needs one set (jacket and pants) = \$4352.
 - Discussion hold off on airpacks and gear on the 2023 budget.
 - o Discussion there are enough funds in the 2023 budget to purchase hose.
 - Priority is to purchase hose, then gear. 750 feet of 1-3/4" hose approved (\$130 per 50 foot) at this meeting + the four vests should be purchased. 1st motion by Tim, 2nd motion by Dusty none opposed.
 - Discussion about 40 duty shirts need to be ordered cost is \$786.
 - Motion to purchase the duty shirts and have Country Home Security do the install of the two cameras. 1st motion by Tim, 2nd motion by Bill – none opposed.

Old Business

- Various jobs around the firehouse to complete nothing to report.
- Landing zone update nothing more to report.
- Roof project updates it was noted that we did not get the O'Connor Grant for the roof project.
- Reminder SJFD budget workshop is scheduled for Friday, August 25th at 6:00pm
