Reports / Requests from Fire Department Chiefs

- Chief Van Etten
 - Noted 2024 was the department's busiest ever with 211 calls.
 - Waiting on V-grant information so can move forward with turnout gear order. Prices are scheduled to increase 8% effective 2/1/2025 which would mean \$16K added to the cost of what needs to be ordered and has been on hold. Also awaiting funds from Assemblyman Chris Tague.
 - Shared an email on behalf of George about EMS equipment and supplies in the firehouse and on the fly car.
 - Shared on behalf of George that at the last department meeting, Access Compliance was approved to do the department physicals this year. Approved − 1st motion by Bill, 2nd motion by Peter − none opposed.

Old Business

Continuing issues with the bay doors – especially the fly car door due to high volume of calls. Discussion to reach out to Oneonta Garage Doors to get a quote (approx. \$2500 per door) and have all doors done next year.

New Business

- Peter
 - Discussion about Chevy seatbelt inspection notification will look into.
 - o All trucks seem to be in good shape.
 - o 2713 has a marker light out it was suggested to make sure it's not a multiplex issue first.
 - 2712 scene light is out discussion to replace with LED lights approved. 1st motion by Dusty, 2nd motion by Peter – none opposed.
- Bill
 - Regarding a recent call and the need for CO monitor he had it at home as there was an issue with it, but it now works and is back on the truck.
 - o Cancer insurance listing discussion about eligibilities and trainings required.
 - Discussion about keeping the call numbers up to date on the website. Since Bill knows how to do and is re-counting what Don reports at the department meetings, the information will be shared to Bill so he can post on the website.
 - Noted he went to the Town of Gilboa board meeting and he said they appreciate SFD. There was discussion about Schoharie County ambulance responses, no longer consistent, and about Headwaters EMS answering calls in the Town of Gilboa.
 - Need SCBA face pieces ordered awaiting the grant funds.
- Andrea
 - \circ Noted has a lot of grant applications submitted -13 hopes to hear back on them. Discussion that not all grant agencies send a reply if you will receive funds or not.
 - Will look for grants for building repairs.
- Tim
 - 2761 purchase status
 - o one department came to view the truck very interested, but no longer and noted that the truck was too big.
 - Discussion about a dealer/broker down South would need to lower the current asking price

 we are not interested at this time.
 - o Discussion if should lower the current price of \$205K will continue to hold at price.
 - Discussion about Fire Tech and Blaise Bojo listings for the truck. We need to get the word out and will try posting on social media too.
